
Manitoba 18th Annual CUPE Winter School

Choose one course from the following four courses and remember to make a second choice, too.

COURSE #1

FINANCIAL OFFICERS/ PREVENTING FRAUD

Jodi Jowett, CUPE Member Facilitator & Debb Grimaldi, CUPE Representative

This two-part workshop is designed for all Financial Officers – Treasurers and Trustees, and also for Executive members.

The first part of the workshop will help you understand the role of the Treasurer and Trustees in your CUPE Local. New Treasurers will learn how to keep a set of books, report to the membership, develop budgets, and work with Trustees. New Trustees will learn all the skills needed to audit their Local's books. More experienced Financial Officers can get up to speed with CUPE's ledger and associated forms, and spend time practising with the on-line ledgers.

In part two of this workshop, we will review the role Financial Officers, Executive members, and CUPE staff play in developing sound financial practices and in preventing fraud. Learn how the Courts are dealing with Local Union fraud cases and understand the financial controls you Local can put in place to make sure you are protected. Find out what kinds of motions might violate the Constitution, or not hold up to scrutiny by an auditor or even the Court. And what about those honourariums, per diems and lost wages – what's taxable and what's not?

HEALTH AND SAFETY: WHAT A UNION ACTIVIST NEEDS TO KNOW
