DAY 1 PLENARY SKILLS SESSION MAY 1, 2023

WORKSHOP STREAMS

ADVANCED STEWARD LEARNING SERIES

Ric McAlpine and Dale Edmunds

Calling all Stewards! The Steward Learning Series recognizes that the shop steward plays a key role in the workplace and the Union. This session provides an opportunity for stewards to explore advanced topics.

This Spring School presents the following modules from the Steward Learning Series:

♦ Handling Discipline and Discharge

Learn about key legal concepts and terms, and the role of stewards during an employer's investigation, when discipline is given, and during grievance meetings.

♦ Representing Members in Front of Management

This module equips stewards to be proactive when meeting with management. Learn tips for effective meetings, and build confidence by practicing meeting situations.

♦ Mental Health and Psychologically Safe Workplaces

What is a psychologically healthy and safe workplace? Learn to identify the psychosocial hazards in a workplace, and the role of the steward in eliminating them.

♦ Conflict Skills for Stewards

Unresolved workplace conflict is stressful and weakens the union. Learn about the sources of workplace conflict and how to choose a response that fits the situation. Practice conflict communication skills that will help you resolve conflict at work and in the union.

In order to register, you <u>must</u> have completed the Introduction to Stewarding workshop. Delegates are expected to attend for the full duration of all the SLS modules, even if they have previously taken a module(s).

COURSE #2 ADVANCED HEALTH AND SAFETY LEARNING SERIES

Stephen Terichow Parrrott and Morgan Chagnon

This Health and Safety Learning Series will give participants who have completed the Introduction to Health and Safety workshop a chance to explore advanced skills and knowledge to be successful while working on a health and safety committee or as a health and safety representative or advocate. Members will also learn how they can contribute to social justice causes while improving health and safety in the workplace.

This Spring School presents the following topics in health and safety:

♦ Basics of Incident Investigation

Learn how to identify root causes of workplace incidents, injuries, and diseases, common routes of entry of toxic substances, and your role in the investigation process.

◆ Law and Orders

This module covers the basic origins of health and safety law, how to find, read and interpret relevant section of law and highlights some of the more important aspects of the specific health and safety law that applies to you.

♦ Making Committees Work

This module explores the structure, role and function of health and safety committees, their strengths and limitations, and how they can best work with the legislative framework, and within our union.

Understanding Mental Injuries at Work

New forms of work, job insecurity, work intensification, high demands, violence and a resulting poor work-life balance are resulting in psychosocial and mental health problems in CUPE workplaces. This module focuses on the workplace as the cause of mental health issues, and not the individual. Discuss strategies and actions that actually help make workplaces psychologically healthier and safer.

◆ Update on Manitoba Federation of Labour campaign for Workers Compensation Board to cover mental health injuries.

COURSE #3 CURRENT LEGAL, LEGISLATIVE AND HUMAN RIGHTS ISSUES

Kristine Barr, Sheree Capar and Laura Ross

This course offers and opportunity to learn from and discuss with legal and human rights specialists. Participants will have the opportunity to hear details about important legal decisions, progress on legislative changes, and new frontiers in human rights.

Topics included in this session are:

- ♦ Leading cases, with a focus on new issues in duty to accommodate.
- ♦ Bargaining know-how in areas like bargaining beyond the gender binary.
- ♦ Bargaining for truth and reconciliation, exploring what decolonization language could include.
- ♦ Reviewing the 2013 Accessibility for Manitobans Act delving into what it was intended to accomplish, union and employer responsibilities, and where we are ten years out.

COURSE #4 LEADERSHIP SKILLS FOR THE WIN!

Shannon McAteer, Alex McClurg and Trish Sinclair

Whether participants are new or experienced local executive officers or committee members, in this session, they will be challenged to hone their leadership skills and explore ways of building the power of the union.

This Spring School course offers modules covering:

◆ Leading as a Team

In this workshop, executive teams explore power and responsibility that comes with it, how we work in teams and how to balance our leadership styles to engage the membership and work effectively across diversity.

Strategic Planning

Staff work with locals to put together a strategic planning session. Strategic planning is a collaborative way to set achievable and measurable goals for your local. It will help you determine what will be implemented over a matter of weeks and years so your local can evolve and grow to serve your membership better. It is also a way to build capacity and activism within your local. This is not an off the shelf workshop. Each situation is different and requires a tailor made approach.

♦ Conflict-Ready Executives

In this workshop, participants will explore:

- The value of conflict for effective groups
- How our beliefs about conflict shape how we respond
- The kinds of conflict executives struggle with
- Productive ways to resolve conflict on an executive

◆ Planning for Member Engagement

Learn principles and processes to plan member engagement in your local.

Participants will leave this session with skills not only for effective leadership, but also for activating more members to get involved in their union and community.
