Important information for delegates:

Meals:

Refreshments & snacks will be provided on January 30th and January 31st. As programming goes until 7:30 pm on January 30th, and through the lunch hour on the 31st, CUPE Manitoba will provide dinner (30th) and a lunch (31st) to registered delegates, included in the registration fee. Delegates should indicate on their registration forms if they have any allergies or dietary restrictions.

Parking:

The Lakeview Gimli has parking spaces available on the North side of the building and details will be provided at the time of check in. There is no cost to parking.

Accessibility:

The Gimli Lakeview is an accessible space for delegates using mobility devices.

The sidewalks serving the Gimli Lakeview feature curb cuts for wheelchair access. Automatic doors are located at the primary entrances to the facility. Drinking fountains and restrooms throughout the building's common areas are wheelchair accessible.

A passenger elevator is located inside the Gimli Lakeview and provides access to both upper and lower levels of the building. Elevators are alarm-equipped with a telephone for emergency service, and have accessible tactile Braille call buttons, both inside and outside.

School Sector Conference Representation:

In accordance with CUPE Manitoba's School Division Sector Terms of Reference (Article 3 – Annual Conference), representation shall be as follows:

Article 3.5:

The number of delegates who may attend CUPE Manitoba School Division Sector Conference shall not be limited, and they shall be seated for all conference proceedings. The number of voting delegates for elections shall be determined by the paid-up membership including Rand Formula payees to the end of the month previous to the month in which the conference call is sent out.

Article 3.8:

Representation by local unions or units (based on the school year September to June) shall be:

Up to 50 members - 2 delegates

51 – 100 members - 3 delegates

101 – 150 members - 4 delegates

151 – 200 members - 5 delegates

201 – 250 members - 6 delegates

251 – 300 members - 7 delegates

300+ members - one additional delegate for each 100 members or portion thereof.

Article 3.9:

Each local union shall be responsible for payment of registration for each voting delegate or non-voting delegates and registration fees shall be submitted to the Treasurer of CUPE Manitoba before commencement of the conference.

Scent-Free Conference:

Delegates to the CUPE Manitoba Convention in 2008 passed a resolution calling for all conferences, conventions, and events to be scent-free that CUPE Manitoba observes to this day. Increasingly, workers are becoming sensitized to chemicals in the environment. For many workers attending events and being exposed to perfumes, colognes, or body sprays can be a serious health risk.

As a result, delegates, participants, and guests are asked to please not wear any scented products during the Conference.

Bottled Water Ban:

Delegates to the 2011 CUPE Manitoba Convention passed two resolutions regarding bottled water that CUPE Manitoba observes to this day:

CUPE Manitoba will:

- Continue to support the ban of bottled water from all CUPE events; and
- Support the call on other Unions and Organizations to ban bottled water; and
- Refrain from purchasing and/or using bottled water when clean tap water is readily available.

The 2026 CUPE Manitoba SDS Conference will be served public water at the Lakeview Gimli.

To ensure we are fostering safer & more inclusive spaces at the 2026 School Division Sector Conference, please reference Article 15 - Code of Conduct (2023 CUPE Manitoba Bylaws & Policies):
